

An alien is a student entering the Republic of Lithuania to study under a student exchange program drawn up by an international higher school or a higher school registered and operating in the Republic of Lithuania and a foreign higher school

(Clause 70.1 of description of visa issuance procedure)

The alien shall not be required to pay the fee.

The alien's fingerprints shall be captured and recorded.

Documents to be submitted by the alien to obtain a multi-entry national visa:

<input type="checkbox"/>	<p>the prescribed application form for national visa filled out using electronic means for filling applications (the application should be filled out in Latin characters, printed and submitted together with other documents required to obtain visa).</p> <p>You can fill out the application for national visa at https://visa.vrm.lt/epm/. <input type="checkbox"/>	<p>a valid travel document (issued within the previous ten (10) years, its validity period being at least three (3) months longer than the validity period of the requested visa);</p>
<input type="checkbox"/>	<p>one (1) 35x45 mm colour photo;</p>
<input type="checkbox"/>	<p>a document certifying that the alien has sufficient funds (e.g., a bank account statement) and (or) receives a regular income (e.g., a scholarship confirming document):</p> <ul style="list-style-type: none"><input type="checkbox"/> to live in the Republic of Lithuania (sufficient means of subsistence equal to 0.5 of the minimum monthly wage per month);<input type="checkbox"/> to return to the country of his or her origin or a foreign country to which the alien has the right to depart (sufficient amount of funds required to return equals to one (1) minimum monthly wage);
<input type="checkbox"/>	<p>evidence of medical insurance:</p> <ul style="list-style-type: none"><input type="checkbox"/> <u>guaranteeing payment of all emergency medical costs as well as expenditures which may arise in relation with the alien's return to a foreign country due to health reasons</u> (such as transportation, including accompaniment of a healthcare specialist(s)) as defined in the Republic of Lithuania Law on Health System;<input type="checkbox"/> <u>covering the entire period of the alien's stay</u> in the Republic of Lithuania.<input type="checkbox"/> the amount of insurance must not be less than EUR 30,000;<input type="checkbox"/> covering the entire period of the alien's stay in the Republic of Lithuania and valid in all participant states of the Schengen Area.

A civil servant of the Visa Office shall be entitled to ask for additional documents supporting the data specified in the application for national visa.

Should the alien fail to submit all required documents to the Lithuanian Visa Office and (or) specify all documents in the application for national visa, the application and supporting documents shall be returned, reasons for return shall be stated by word of mouth and required information shall be provided.

The application for national visa and the documents referred to herein shall be submitted to the Lithuanian Visa Office abroad and processed *mutatis mutandis*, applying provisions of Clause II and Clause III of the Visa Code.
